



PURCHASING CONTRACT

It is agreed between Seller and Buyer as follows:

1. DESCRIPTION OF DOG:

2. SELLER'S REPRESENTATIONS

A warranty against genetic defects is provided for two years after the date of sale, related cumulative reimbursement limited to 50% of the purchase price. Genetic defects that qualify for reimbursement are those related to hip, heart, elbow, patella, eye, or life-threatening issues. Reimbursement for genetic defects will be made only when a second opinion from a qualified veterinarian and proof of surgery expenses are provided.

An official OFA hip rating will qualify as a second opinion. Umbilical hernia repairs will be reimbursed up to \$200. In the rare case of death (Daisey's Doodles is at zero), the puppy will be replaced free of charge if under 2 years of age. A necropsy report completed by a qualified vet must show the cause of death was caused by a genetic issue. Shipping fees are at the buyer's expense. Seller agrees to rehome the dog should the original purchaser so request. Warranties shall apply only to the original purchaser. This warranty is void in the event of an indeterminable or inconclusive diagnosis. Transfer of dog ownership shall void all such provisions of this agreement.

Seller makes no guarantee this dog will not shed or cause an allergic reaction. Buyer understands that Seller's prediction of coat type, height, and weight at adulthood are estimates only and are based on Seller's goal to match puppies with families appropriately.

This dog must be spayed or neutered before 12 months of age and failure to have this done will void the health warranty. Proof of spay/neuter must be provided to Daisey's Doodles within 30 days of the procedure being completed to maintain your warranty. Proof of spaying/neutering by 12 months of age must accompany any request for warranty reimbursement. This puppy is being sold as a family pet and does not come with breeding rights, unless arranged otherwise.

Under no circumstances shall the Seller be liable to the Buyer or to any third party for a dog that has been subjected to abuse, accident, negligence or misuse. Also, under no circumstances shall the Seller be liable for any consequential incidental or special damages resulting from or in any manner related to the dog.

Upon execution of this contract all veterinary care and its associated costs are the sole and exclusive responsibility of the Buyer.

3. CONSIDERATION

This dog, identified in Section 1, is being sold for the sum of \$, paid in full at the execution of this contract.

4. MAINTENANCE

Buyer agrees to maintain this dog in good health, provide preventative health care including, but not limited to, inoculation, internal parasites, and -- where indicated -- heartworm preventative medication. It is agreed that your Doodle will be housed indoors and fed quality food. It is also agreed that you will maintain the dog at a healthy weight. Buyer agrees to postpone strenuous, repetitive exercise (such as agility training or running miles a day) until a minimum of one year of age to protect joints and hips or as advised by a vet. Buyer agrees to provide basic obedience training within the first year of ownership.

Buyer agrees to never place this dog in a shelter, pound, or similar facility including a research laboratory. In the event that the Buyer desires to sell or give away the dog, the Buyer grants unto the Seller the first right of refusal. The doodle can also be returned to us at any time for any reason. Seller agrees to answer the Buyer within two weeks with a written response indicating the Seller's decision to reacquire the dog. Texting/messaging, is usually the most efficient way to reach the Breeder in a prompt matter.

I understand and agree to this policy.

Buyer agrees that usage of any regular monthly oral flea and tick preventatives voids the warranty completely in relation to neurological issues, seizures and other related health issues. This is due to the FDA warning about these products causing neurological issues such as seizures and other health issues in dogs. Vets give out oral preventatives like candy. Monthly chemicals in a dog's systems can cause unnecessary health and neurological issues. We recommend topical treatments and only treating as necessary when your dog has actual fleas. An occasional oral treatment can suffice when fleas are severe, only when necessary.

In addition, many candles, diffusers, incense and essential oils are toxic to pets and cause neurological issues such as seizures. Buyer agrees to research all such products and only use pet-safe products.

I understand and agree to this policy.

5. CONFIDENTIALITY OF DISPUTES

Buyer and Breeder agree, that in the event of a dispute between them, neither will publish or communicate the existence or content of such dispute in any media or forum, including social media, provided that this provision shall not be interpreted so as to prevent either party from bringing legal action or engaging in confidential mediation as herein provided.

6. HEALTH ADDENDUM

Buyer understands that puppy is going home with all age-appropriate vaccinations but these are *first* vaccinations. A puppy is not fully vaccinated until closer to 16 weeks (consult your vet on the proper vaccination schedule for your dog). Until this time, your puppy is at risk for serious illness such as parvovirus, leptospirosis and distemper. Your puppy's paws should not be on the ground where exposure to other potentially unvaccinated dogs (or their urine or feces) is possible. This means no dog parks, public fields, beaches, boardwalks, pet stores, etc. Grass and sand are the highest risk. When this is absolutely unavoidable, concrete is the safest option but paws should immediately be washed with soap and water.

I understand and agree to this policy.

7. FULL AND FINAL AGREEMENT

The parties agree that this writing represents the entire Agreement between them and that no other representations, either oral or written have been made regarding the dog described above. The parties further agree that no changes in this contract shall be binding upon either of them without written modifications signed by both parties. Buyer agrees that s/he understands this contract fully, and that this contract is under the jurisdiction of the State of WA, in the county of King.
